

KidSpace Fees

Effective November 1, 2011

- Beginning November 1, 2011, all participants in KidSpace must provide their proof of gross income whether or not they pay visitation fees.
- Gross Income is based on last year's federal tax return, last year's W-2 form, two (2) recent consecutive pay stubs, or government-issued benefits letter. Any other proof of income must be approved by the Program Coordinator.

Hourly On-Site Supervision Fees

Total Household Annual Gross Income	Hourly Fee
Under \$10,000	\$10
Under \$20,000	\$30
\$20,000 - \$29,999	\$35
\$30,000 - \$39,999	\$40
\$40,000 - \$49,999	\$50
\$50,000 - \$59,999	\$60
\$60,000 - \$69,999	\$70
\$70,000 - \$79,999	\$80
\$80,000 and over	\$90

- Hourly fees will be reassessed after 12 months of visits at KidSpace and adjusted accordingly. If proof of income is not provided within 60 days of request, fees will be **\$90** per hour or visits will be cancelled. Persons who fail to provide sufficient documentation of income will pay the hourly rate of **\$90**.
- Fees for supervised visitation must be paid prior to visit.
- KidSpace accepts cash, money orders and bank checks. No personal checks accepted.

Other Fees

- **Intake: \$30:** paid by each party (Custodial and Non-Custodial/Visiting Parents/Parties).
- **All Open Adoption Visits** and **Short-term Visits** (1-3 visits per year): **\$50/hour** minimum
- **Visitation Summary:**
 - * **No Charge:** when sent to Court, Custodial and Non-Custodial/Visiting Parents prior to a Review, Hearing or Trial.
 - * **\$30:** when requested by either party not in conjunction with a Court appearance.
- **Copy of Observation Notes: \$50,** up to 200 pages through a subpoena; **\$.25** per page thereafter.
- **Safe Exchange Fees:** KidSpace charges a set fee of **\$30** for the Safe Exchange service. The visitation fee must be paid at the time of safe exchange or the exchange will not occur.

Due to increased costs associated with the program, KidSpace has been forced to increase our fees. The attached fee schedule is effective November 1, 2011.

Other changes:

- **Intake Fees:** \$30 paid by each party
- **All Open Adoption Visits and Short-term Visits (up to 3 visits per year):** \$50/hour minimum.

Hourly Fees will be reassessed after 12 months of visits at KidSpace and adjusted accordingly. If proof of income is not provided within 60 days of request, fees will be \$90 per hour or visits will be cancelled. Persons who fail to provide sufficient documentation of income will pay the hourly rate of \$90.

We regret this increase taking place in our current economy and hope this will not affect your ability to participate in KidSpace
