ORDER FOR SUPPORT & HEALTH CARE COVERAGE

I. Child, Spousal and Medical Support

- The plaintiff - defendant (obligor) is ordered to provide support payments in the sum of \$ _____
 weekly bi-weekly monthly .
\$ _____ shall be considered current child support and \$ _____ current spousal support.

Should health care coverage for the dependent child(ren) - and spouse - not be provided for any period for which it is ordered, the amount of the support order for that period is increased to \$ _____.

 18th 21st 23rd birthday of the child - youngest child, unless otherwise ordered by the Court.

II. Payment Information

- All child support payments shall be made by income assignment through the Department of Revenue (DOR).
 The obligor shall make child support payments to DOR at PO Box 55144, Boston, MA 02205-5144 until the employer begins making deductions. The obligor will be credited only for payments made to DOR.
 Pursuant to a written agreement of the parties or a finding of the court, attached hereto, the income assignment in this order is suspended and payment shall be made by the obligor directly to the custodial parent (obligee). If enforced by DOR, the income assignment shall take effect immediately when a total arrearage amounting to the support owing for a 14 day period has accrued, or, in the case of a monthly order, 14 days after a payment is missed or, after one half of the monthly support owing is missed. The income assignment provision shall take effect immediately upon the request of either the obligor or obligee.

III. Health Care Coverage Provisions

- The plaintiff-defendant is ordered to provide health care coverage for the dependent child(ren) - and spouse as follows:
 Maintain current health care coverage.
 Immediately. Notify DOR when health care coverage is in effect.
 If and when it becomes available at reasonable cost. Notify DOR when health care coverage is available.
 The obligation to provide health insurance ends on _____
